### **Qualifying Holding in CTT**

CTT – Correios de Portugal, S.A. ("CTT") hereby informs, under the terms and for the purposes of article 17 of the Portuguese Securities Code that it has received today from Barclays Plc the following communication of a qualifying holding:

#### **RE: CTT CORREIOS DE PORTUGAL SA – DISCLOSURE OF INTEREST**

1. Barclays Plc, a company incorporated under laws of the United Kingdom, with its head office at 1 Churchill Place, London E14 5HP ("**Barclays**"), hereby informs the Comissão do Mercado de Valores Mobiliários ("**CMVM**") in accordance with and for purposes of the provisions of article 16 paragraphs 1 and 2 of the Portuguese Securities Code (hereinafter "**PSCode**") and Article 2-A/2 of CMVM Regulation 5/2008, that it is now interested in 2.76 % (4,132,950) of the voting rights pertaining to the share capital CTT CORREIOS DE PORTUGAL SA as of 21 May 2015.
2. Barclays' overall interest in the voting rights pertaining to the share capital of CTT CORREIOS DE PORTUGAL SA has crossed the initial discloseable threshold of 2 % due to the purchase of 1,980,000 shares by Barclays Merchant Bank (Singapore) Ltd on 21 May 2015.
3. Pursuant to article 16, paragraph 4 of the PSCode, in conjunction with article 20, paragraph 1(b) of the PSCode, we further inform CMVM that the referred qualifying holding is attributable to Barclays, directly or via companies with which it is in a domain or group relationship, as follows:
