("CTT" or "Company") hereby informs, under the terms and for the purposes of article 17 of the Portuguese Securities Code, that on 10 April 2017 it has received from BNP Paribas Investment Partners a disclosure for Parvest Equity Europe Small Cap fund holding in CTT Correios Portugal going below the 2% threshold on voting rights as shown below. It should be noted that the last disclosure dates back to a notification done in name of BNP Paribas Investment Partners S.A. for holdings on 29/01/2016 going over the 5% threshold. It was valid for disclosures on multiple levels, which the Parvest Equity Europe Small Cap fund was part of.
